## Satisfied records

Records on the Registers that are paid in full and where the defendant has supplied proof of payment to the court (for England and Wales records) or Registry Trust (for other regional records), are satisfied records.

## No records found

A 'no records found' result is returned, when the records held on the Registers do not match the details searched.

No records found can mean that either:

- there are no records registered against the details provided in the search request
- the details searched are not accurate i.e. the incorrect address was searched

## Information on the Registers

The records on the Register contain the following information:

- The name and address of the defendant
- The date of birth of the defendant - where provided
- The court and case number
- The amount and date of registration
- The satisfaction date if applicable

The defendant's details on the Registers, appear as the claimant has provided them to the court.

## General

- A search is conducted against the details that you have submitted; addresses are not linked together on the Registers.
- The claimant's details are not provided in the search result, as they are not held on the Registers. The defendant is able to obtain the claimants details from the relevant court.
- Details of defaults, bankruptcies, individual voluntary arrangements (IVAs) and company voluntary arrangements (CVAs) are not held on the Registers.
